- Someone with a heart to see young people grow spiritually, who works hard to release their potential.
- A team builder, experienced in training and equipping.
- Energetic, flexible and a visionary.

- Qualified with a relevant youth work qualification or the nationally recognised JNC qualification and/or have a minimum of 5 years experience of face-to-face work with young people.

- Able to drive and has access to their own reliable transportation and can carry out any other reasonable duties within the overall function, commensurate with the level of responsibility of the post.
- Able to support young people and act with integrity during challenging times.
- An active listener with the skills and ability to solve problems as they occur.
- Able to demonstrate strong time management and prioritisation skills in order to be effective.
- Able to present or register for a valid and recognised First Aid course.
