Restore is an incorporated charity founded by Christians to provide housing and support to people in the city and surrounding areas who are experiencing homelessness.

***Our vision** is for a York where everybody has a home, where those who have been homeless before are rebuilding their lives, and where the city works together to beat the underlying causes of homelessness.*

The charity has built up an excellent reputation in the city for successfully supporting its residents ready to move on into a property of their own.

Restore currently manages 14 properties, mainly houses in multiple occupancy, which provide supported housing for 40 single people, plus two properties for refugee families.

Restore employs a number of staff to provide support, raise funds, property maintenance and to manage the day-to-day operation. There are further plans to expand the operation with more properties and a larger staffing team.

The board of trustees and directors are the people who lead the charity and decide how it is run. Each of them is expected to bring and invest their individual skills to provide governance for the charity in line with the requirements of the charity commission and for the wellbeing of staff and the community we serve. All trustees are volunteers and are therefore unpaid but may claim reasonable expenses. In keeping with the aims of the charity all trustees are expected to have an active Christian faith.
